The participant hereby agrees to participate in a Junipero Serra Swim League club swim program and hereby agrees to indemnify and hold harmless Junipero Serra Swim League, its coaches, officers, directors, agents, employees and volunteers against any liability resulting from any injury that may occur to the participant while participating in a Junipero Serra Swim League club swim program. The participant also agrees to indemnify Junipero Serra Swim League for any damages incurred arising from any claims, demand, action or cause of action by the participant.

The participant authorizes any representative of Junipero Serra Swim League to have the participant treated in any medical emergency during their participation in any Junipero Serra Swim League club program. This authority is granted only after a reasonable effort has been made to reach me or this medical emergency is either life threatening or creates undue discomfort and should not be delayed. All emergency costs are the liability of the parent/guardian and not the staff member who is trying to aid the participant.
